

Important information for students entering Year 1 in AY 2024/2025 concerning accommodation at USB Dormitories

Please read carefully, the following text contains all the necessary information!

1. Future first-year students who are interested in applying for on-campus accommodation should submit an electronic application to <https://koleje.jcu.cz> between 1 July and 31 July 2024. Use the link 'Login others to ISKAM'. LOGIN: student's identification number (without the slash symbol), password: initials in small letters (always only 2 letters, e.g. Jan Novák-jn). If you cannot log in, use the link to send a new password. After enrolling in studies, use <https://koleje.jcu.cz>, link 'Student Login to ISKAM', to log in to ISKAM. The login details are the same as for STAG. A confirmation email will be sent to students who correctly submit the accommodation request.
2. D&R USB will decide on the accommodation of applicants under Accommodation Regulations No R544 by 5 August 2024. An email will be sent to applicants with approved applications at that time with further instructions.
3. Prospective students, whose application has been approved and who are still interested in accommodation at the dormitories, will pay a reservation deposit of CZK 3 000 by 25 August 2024. This reservation deposit will be converted into an accommodation deposit on the day of arrival.

The deposit can also be paid online by logging into your ISKAM account (see point 1 for login) at <https://koleje.jcu.cz/>.

In the event that the reservation deposit is not paid by 25 August 2024 at the latest, the right to the reservation will expire.

The reservation deposit paid is non-refundable in the case that the student does not check in or cancels the reservation.

4. In the case of underage students, a certified parental consent (download [here...](#)) is required.
5. Prospective students according to point 1, who have been granted accommodation in dormitories and who have duly paid the reservation deposit by 25 August 2024, will be assigned a specific dormitory and room by D&R USB by 31 August 2024 at the latest. First-year students are not entitled to a choice of dormitory or room!
6. Requests for shared housing by students, including couples, whose applications have been approved must be addressed in advance, no later than 9 August 2024, by written request from both students to kam@jcu.cz.

7. The accommodation can start at any time from 20 September to 26 September 2024 including weekends. The dormitory receptions are open 24 hours a day.
8. Upon arrival at the accommodation, the student will pay the rent according to the price list from the date of arrival until the end of October (depending on the number of nights), either by credit card or in cash at the reception of the college.
9. Students who do not submit their application on time or whose application is not approved, and students admitted in the second round of the admission procedure who wish to apply for accommodation, can submit an electronic application from 6 August 2024 at: <https://koleje.jcu.cz>.

Late accommodation will be arranged individually according to availability. The applicants will be informed about the possible allocation by phone or e-mail.
